Innovation Network Schools operate with the authority to make decisions about certain aspects of their school—both academic and operational. They are held accountable by the school district for achieving high academic goals and strong student achievement. The purpose of Innovation Network Schools is to allow our district, and schools within our district, greater flexibility to make decisions based on the specific needs of a school’s student body. In IPS, there are five pathways a school may take to become an innovation school:

A new school may launch in partnership with IPS as an Innovation Network School within the IPS LEA.

A lower-performing existing IPS school, with community support, may convert to innovation status as a self-initiated improvement strategy.

| Non LEA | The Partner Operator is responsible for all Special Education services. If a school moves from the IPS LEA to Non LEA, IPS is no longer able to provide Special Education services or staffing within the partner school’s LEA. |
| Split LEA | Non LEA with USS Programs - USS is responsible for providing Special Education services and staffing for the USS programs located in the Partner Operator’s school. Programs include: PYC, Life Skills, etc. |
